#### Item #2- Public Comment on a non-agenda item

Kara Moody, Resident of Magrath Rd-She is requesting an update.

Perry is continuing with the research. He has spoken with our Town Attorney. It looks like we should be plowing this road along with two others. Perry will need a plan to move forward with this. One issue is easements. The Town will need an easement for Magrath Road. We are not sure on the Cemetery Road. Magrath Road is in need of work. A smaller truck is recommended for plowing purposes. The road closure process takes place between May and October. Perry will have a full report at the next meeting. The Town is looking to get the Road Committee together soon. In order to close a road, a Public Hearing is needed.
